1.00 APOLOGIES FOR ABSENCE:

Apologies for absence were received from Councillor J. Eagles.

Item 3 relating to the proposed Tesco store in Bingham brought forward to allow Mr. M. Magee from DLA Piper to give a presentation.

3.00 TESCO - PRESENTATION ON PROPOSED BINGHAM STORE:

The Town Mayor, Councillor Mrs. M. Stockwood, welcomed Mr. Matt Magee of DLA Piper to the meeting. After giving apologies on behalf of Eoin Dardis, Mr. Magee confirmed that 362 feedback forms had been received of which 75% had been in favour, 14% opposed and 11% undecided. The main concerns voiced were for the volume of traffic and impact on the town centre.

Mr. Magee confirmed that, mainly, people were travelling outside Bingham to shop, and the aim of Tesco was for Bingham to retain the shoppers and thus boost economy within the town. It was hoped to have a bus stop within the Tesco site but whether or not there would be a need for additional services, or the extension of current services, was yet to be determined. A draft transport assessment and a micro-simulation model were being prepared and a landscape assessment was being addressed by a landscape architect and ecologist focusing on pedestrian linkage; planning application should be submitted by mid October, although this date was running behind schedule initially suggested.

Councillors' concerns and questions were mainly as follows:-

1. The level crossing and additional vehicles which could cause a gridlock backing up along the main roads.
2. Would the current roadworks on the A46 improvements mean the old A46 could be utilised to ease any traffic problems incurred due to the barriers on the level crossing?

3. Would more traffic be generated by shoppers entering Bingham from outside the area? Mr. Magee confirmed their plans had been prepared based on shoppers only in the catchment area of Bingham.
4. Pedestrian-linkage was a high priority in relation to traffic and the footpaths.

Mr. Magee confirmed that once the planning application was ready for submission, a further meeting with the Town Council would be beneficial.

The Town Mayor, Councillor Mrs. M. Stockwood, thanked Mr. Magee for attending.

2.00 MINUTES:

10 Folio 6109/8.01 – Harry Beet, V.C.0

It was

RESOLVED to progress a plaque in St. Mary & All Saints Parish Church to recognise Harry Churchill Beet's achievement in receiving the Victoria Cross (Folio 6109 refers). It was acknowledged that whilst Harry Beet was born in Bingham, he left the area whilst still a child.

5.00 OTHER REPORTS:

01 County Councillor Martin Suthers

Councillor Suthers reported that three main areas have been addressed recently, these being:-

- (a) Tesco
Concerns re. the strategic issue of transport links.
- (b) Cycle Links
Councillor Suthers said that, in his capacity, no-one had ever requested any cycle lanes, yet other highways issues had been raised, i.e. a ramp on Cogley Lane instead of a step and interactive speed signs. He stressed that the cycle lanes were not compulsory and suggested they were not a fait-accompli.
- (c) Health Centre

Councillor Suthers said he was concerned that a recent newspaper article suggested that the Arnold Health Centre project was stalling, and expressed concerns that this may jeopardise the plans for Bingham.

6.00 PRESENTATION OF PLANS FOR PROPOSED COMMUNITY CENTRE. UPDATE:

Councillor Purdue-Horan confirmed that additional coloured plans had been provided by the architect for a generic Community Centre, i.e. not site specific. At the appropriate time, a public consultation would be held.

Reference was made to the letter under correspondence received from Mr. Ashton. Councillors confirmed it was impractical to build the proposed Health Centre on the Robert Miles Junior School site and also that the Town Council would not support such a proposal. Councillors would not want to jeopardise the opportunity for Bingham to have a new Health Centre and the plans put forward did not fit in with current timescales.

02 Mr. S. McRobie

Mr. McRobie thanked Bingham Town Council for developing Butt Field in partnership with the Sports Clubs and said that the facilities were a great asset. He said that the previous weekend had been a family one on site which was a great success,. (Ninety-three cars were in the car park on Butt Field). He told Councillors there had also been a successful trip to Bingham's twin town of Wallenfels, and thanked the Town Council for grant aid in making this possible.

03 Mr. R. Landon

Mr. Landon expressed concerns over Bingham Town Council insisting that licence for the fruit and vegetable stall on the market place on days others than a Thursday be rescinded. He was aware that a petition with 350 names on it in support of the stall had been sent to the Borough Council. There was a brief discussion, and it was stressed that Bingham Town Council does not have any financial interest with either the market square or any buildings surrounding it. The market square is the responsibility of Rushcliffe Borough Council.
