Tesco representatives gave a short presentation and provided a hard copy of their proposals. Tesco had been in talks with other Authorities, i.e. Nottinghamshire County Council Highways, Network Rail, etc. Councillors' queries were answered in relation to the railway crossings, traffic and link to the bridleway. Tesco was aiming at submitting a planning application by the end of March, and, if permission was granted, the build would be scheduled which could, possibly, be autumn, 2012.

## **6.00 OTHER REPORTS:**

### 01 County Councillor Martin Suthers

Councillor Suthers confirmed that, under the B.B.C. (Building Better Communities) [old scheme name], now called L.I.S. (Local Improvement Scheme) [new scheme name], he was supporting the Town Council's clock project and also the renovation of the wall on Jebb's Lane.

Councillor Suthers confirmed there was a delay with the crossing on Grantham Road due to guidelines stipulating that a toucan crossing has to be installed if vehicles are exceeding the speed limit. A toucan crossing is more expensive to install, therefore, additional funding has to be identified.

Newgate Street was included for resurfacing in next year's budget. Other grant aid had been given to fund the Roman Wall project, a new projector at Toot Hill School, a sensory garden and raised allotments at other schools.

Councillor J. Stockwood gave a brief report on the Newton Community Liaison Group and confirmed there would be public consultation based on display boards around Bingham.

## **7.00 NOTICE OF MOTION:**

It was **PROPOSED** by Councillor Purdue-Horan and **SECONDED** by Councillor Kerry that:-

*"This Council has serious concerns with issues relating to the building of a new Health Centre for Bingham, including:-*

- (a) *Since October, 2009, Nottinghamshire County Primary Care Trust has not communicated with Bingham Town Council or had any appropriate dialogue with elected representatives of Bingham.*
- (b) *Following the announcement of the Nottinghamshire County Primary Care Trust's preferred site of Mill Hill in 2009, there has been no confirmation as to whether this site has been pursued or acquired.*

*This Council requests an urgent meeting with Nottinghamshire County Primary Care Trust to be updated with relevant information and to ensure all possible options are explored to improve the provision of health care services to all residents of Bingham".*

**8.00 NOTTINGHAMSHIRE COUNTY COUNCIL BUS STOP/STANDS PROPOSALS:**

After a brief discussion, Councillors agreed to a letter being sent to the County Council, reporting that the short consultation period was unacceptable and requesting an extension of the period. The proposals were unacceptable for various reasons, including the following:-

- 01 The area falls within a conservation area.
- 02 The proposed stand outside The Chesterfield Arms and The Old Court House would present problems for other road users and residents. It would also impair the view which forms part of Bingham Heritage Trail.
- 03 The extension in front of the Co-op would present problems for mobility scooters as the location of the dropped crossings would mean users having to pull on to the road without a clear vision of vehicles coming down the road.
