2.00 APPOINTMENT OF VICE-CHAIRMAN:

Councillor A. Shelton, **Proposed** by Councillor Mrs. M. Stockwood and **Seconded** by Councillor F. Purdue-Horan, was duly elected as Vice-Chairman for the ensuing year.

Standing Orders were suspended for the following item.

3.00 PRESENTATION BY BINGHAM BUSINESS CLUB:

Richard Wollacott reported on the format of the newly re-launched Bingham Business Club with breakfast and lunch meetings taking place every month. The Club had been well received so far with membership numbering between 20-25 from a range of businesses, and enthusiasm for the Club to become a focal point for businesses in Bingham. A new website would be the starting point for a directory of businesses in Bingham. In anticipation of this presentation, Mr. Wollacott had canvassed views and opinions from members at recent meetings, and priorities had been identified as follows:-

01 Car Parking

This was a long-standing problem in the town. Car-parking was required for both shoppers and business staff, and it was, therefore, essential that long-term parking was provided for workers.

02 Town Centre Congestion

The Bingham Business Club was in favour of a one-way system in the Market Square which would lead to the easing of congestion in the town.

Other Issues

- The Town Council should support applications for new businesses in the town, regardless of type.
- The Town Council could do more to promote the town as a business centre and attraction for visitors.

The following points were raised by councillors in response to Mr Wollacott:

- Some of the issues mentioned by Mr. Wollacott had been raised before.
- The Town Council would encourage a link from the Bingham Business Club to the Town Council's website.
- The Town Council promotes the town as much as it can through the Promotions Working Group. It welcomed the re-launch of the Bingham Business Club as it could only assist the promotion of business in the town.
- It was explained that the Town Council's role in the planning process was as a statutory committee and not as a planning authority. As the designated areas for different business categories had been drawn up long ago, steps were now being taken to have the area re-defined.
- The Town Council was happy to support the Bingham Business Club in its endeavours and was particularly interested in the recently launched Nottinghamshire County Council Travel Plan which helped businesses share spare parking spaces. The emphasis had shifted from the previously-held view that shoppers 'Park & Ride' to Nottingham, to a need for parking for workers. It was felt that the Nottinghamshire County Council proposals were weak as many workers come in from outlying areas with poor public transport facilities. The feasibility of providing a small park & ride car park on the edge of the town was discussed
