It was

**RECOMMENDED** to respond as follows:-

1. The housing requirement for Rushcliffe, compared to other parts of Greater Nottingham, is disproportionate and inequitable. It is extremely difficult to envisage how such a number of dwellings can be provided in a sustainable manner.
2. Bingham Town Council supports the omission of large development sites near Bingham (former R.A.F. Newton, land to the north of Bingham).
3. While accepting that there should be some housing development in Bingham, this should be very limited in extent (given the development that has occurred in the town already) and largely restricted to affordable social housing for rent.
4. There is not mention of improvements to relevant transport infrastructure in the document. Even with little further development, an upgrade of the A52, improved rail services to Nottingham and ~Grantham, and a rail park-and-ride are all urgently needed.
5. Although not in our parish, any development at R.A.F. Newton would have a significant impact on Bingham. This Council believes that there is scope for limited development at that location, but it would have to be linked to infrastructure improvements in 4 above.
6. This Council is aware that the Crown Estates have a desire for large-scale housing development to the north of Bingham. We believe that any such development is inappropriate at this stage, and that it would be extremely difficult to integrate large numbers of dwellings to the north of the railway to form a united and cohesive town.
