Another reason for the delay was the fact that, to date, the Primary Care Trust had not made an official announcement of the site location for the new Health Centre and this announcement obviously impacts on any decisions Bingham Town Council may make in relation to a community building. Once the P.C.T. announces the site of the new Health Centre, it is feasible that the Town Council may still have discussions with Liftco.

The Town Council has also been involved with another major project, Butt Field, which impacted on its resources as it had to be able to finance expenditure whilst waiting for grant-funding to be received.

**4.00 BUILDING BETTER COMMUNITIES:**

01 Update on Eaton Place Clock Project

Councillor Mrs. Stockwood updated members on the recent assembly at Toothill School, attended by her and Councillor Purdue-Horan. Students are designing clocks and three per tutor set will go forward to be judged by the academy with these winners then being judged by the public following displays at the Library and Old Court House. Prizes will be given at each stage with the overall winner seeing their design in situ in Eaton Place Precinct. It is hoped that the Town Council will also offer a suitable prize. The students will be involved with a clock manufacturer and the project funded by B.B.C. It is hoped that the clock will be unveiled at the next Summer Fair.

**5.00 BINGHAM 2020 “SHAPING OUR FUTURE”**

The Chairman welcomed Councillors' thoughts and ideas on how the Community Committee could address this exciting project. Councillor Mrs. Stockwood made reference to the 2003/04 Market Town Initiative and the elements under the community remit such as community safety – involve police re. anti-social behaviour; youth issues; support for local schools; community building; Health Centre; support for emergency services; support for post office; business database; support for all arts across the board, including craft, theatre, drama; education and health, including U3A.

The Chairman went on to raise the question as to whether or not Bingham's young peoples' needs were being met, i.e. such as sufficient affordable housing, variety of shops, etc.

Whilst the A46 improvements will open Bingham up in the future, will the infrastructure grow at the same rate? Businesses will have to be developed and the future of the market will have to be considered. The Chairman felt there were a lot of areas which the Committee could investigate, and he would distribute his own notes and ideas to Councillors.
