# Rushcliffe Borough Council Leisure Strategy – 2006 to 2016

On 10<sup>th</sup> January 2012, the Cabinet of Rushcliffe BC, approved an update document to the Borough Leisure Strategy. The purpose of the update was to review the future strategic direction of leisure centre provision within Rushcliffe, particularly in relation to potential future population, housing growth and community priorities.

Within the update document, the provision of a leisure centre to remain in Bingham was confirmed as a priority, however, funding of a new facility and a preferred site at some time in the future are the major challenges.

As part of considering and exploring potential options, the published document suggests discussions could be held with Bingham TC with a view to a possible future partnership arrangement for such a site to include a Leisure Centre and a Community Centre.

It was agreed to explore this suggestion further and discussions with Rushcliffe BC will be welcomed.
