Reference was also made to a feasibility study undertaken in 2001 which was evidence of public consultation. This information within the feasibility study was still applicable today.

Councillor Purdue-Horan reaffirmed the relevance of the feasibility study and the fact that the results still stand today. He added that Grange Hall at Radcliffe had become so successful that people were being turned away, and if Bingham had such a facility, this would be able to take on those bookings.

The Community Building Working Group had met on the 16th March, 2009 (see Minutes attached) and had addressed the matters raised in the letter from Community Concern. It was

<u>RESOLVED</u> that the feasibility study be summarised and published on Bingham Town Council's website. Also that an A5 leaflet be prepared, asking for residents' comments, and this to be distributed to every household in Bingham.
