# 5.00 TO CONSIDER REQUEST FOR PUBLIC DEFIBRILLATORS IN AND AROUND BINGHAM:

It was understood from Community Heartbeat Trust (CHT), that the Vale of Belvoir Rotary Club, (VOB Rotary), would consider contributing £1,000 towards the cost of a defibrillator, (approx. £2,106), in Station Street, if a similar contribution was made by the Town Council.

It was considered an excellent proposal as CHT had negotiated the adoption of the redundant phone kiosk and would undertake ownership and maintenance of the site and equipment.

# POLICE PRIORITY SETTINGS GROUP 5<sup>TH</sup> MARCH 2015 RADCLIFFE GRANGE, RADCLIFFE

### Key points:

- No longer any urgent responses from West Bridgford. All 999 responses now come from Riverside (City Centre).
- Police now have no administration to organise community style meetings (like this one). Resources have been cut.
- The Beat Police role is becoming more limited
- · Crime down generally in Rushcliffe South
- Burglaries down across the County
- Cather car used in Radcliffe. Generally this has reasonable success.
- Bingham was red routed for burglaries over December/January, but number of burglaries reduced over this period.
- Clampdown on road users using mobile phones.
- ASB will be watched for as next setting period runs into the summer.

#### **Priorities**

Priorities for next 3 months set as: Speeding (and use of mobile phone clampdown) and ASB.
