There were no declarations of interest received.

APOLOGIES FOR ABSENCE:

Apologies for absence were received from Councillors A. Hall and F. Purdue-Horan.

1.00 MINUTES:

The Minutes of the meeting held on the 14th July, 2009, having been circulated prior to the meeting, were taken as read, approved and signed by the Chairman as a true record.

01 **Matters Arising** (*For information*)

There were no matters arising for information.

2.00 POLICE:

01 Inspector Haywood responded to a written question on C.C.T.V. He reported that the Beat Manager was happy with the existing arrangement and had used recorded data in court on a number of occasions. However, during the hours of darkness, the benefit was significantly reduced due to inadequate street lighting. Inspector Haywood would also recommend an additional camera to overlook Station Street.

Councillor Stockwood responded by saying that the Town Council had looked into installing an additional camera but, despite repeated attempts, could not obtain a licence to locate it in suitable premises on the Market Place.

2.00 **POLICE continued.....**

- 02 Inspector Haywood referred to the new Local Area Group (L.A.G.) scheme which had recently been introduced to the area.

The appointment of a 'Police Liaison Officer' was a way of improving the communication between police and Town/Parish Councils; the aim was that a representative from the Town Council would be nominated as a single point of contact with the Safer Neighbourhood Team, thereby providing the Town Council and community with an improved line of communication to the police. Immediate benefits include monthly crime reports, (funnelled through the Liaison Officer), and an invitation to beat surgeries, (approximately one per month), to represent and address any issues from the Town Council's point of view. The role is voluntary and would not be onerous. It could be filled by an individual such as a member of Council staff, a Councillor or Neighbourhood Watch Co-ordinator.

- 03 Inspector Haywood went on to explain the recently updated Local Area Group scheme (L.A.G.) in which 'Beats' had now become 'Safer Neighbourhoods'. Bingham was now part of a 'Neighbourhood', each of which was obliged to set three priorities. The priorities would be set every three months at Neighbourhood Meetings, the first of which was due to be held on the 29th October, 2009, at Bingham Police Station, and would be the culmination of three months of community engagement throughout the whole neighbourhood.

Once the three priorities had been agreed, they would be publicised and given an enhanced response of action within one hour of reporting. For example, if Priority No. 1 was defined as anti-social behaviour in Bingham Market Place and a report was received by the police concerning a related problem, action would be taken within one hour of the report being received.

Any other issues arising from the consultation would not be sidelined but would be actioned as required.

Following the quarterly meetings, groups would report back on the level of success achieved in addressing the priorities.

The aim is to have students produce models of their designs which will be displayed in the library during the consultation period over Christmas. It is anticipated that the winning design will be manufactured in time for the clock to be installed by the end of March, 2010.

It was made clear that the Town Council had no ownership or interest in any property in the centre of Bingham, neither had it any jurisdiction over the activities on the market square.
