- 01 <u>Planning Committee</u> –18th November and 9th December, 2008. Councillor Shelton reported the Minutes were self-explanatory and these were agreed and accepted.
- 02 <u>Community Committee</u> –18th November, 2008. Councillor Purdue-Horan gave a brief report and confirmed that the Community Building Working Party group had referred an item to the Policy & Resources Committee re. an additional expenditure of £1,500.00 for a detailed plan of a community centre. - 04 <u>Environment Committee</u> 9th December, 2008. Councillor J. Stockwood gave a brief report and update. The glass recycling project by Rushcliffe Borough Council would be addressed by Cabinet and a decision made by March, 2009.
- 05 <u>Policy & Resources Committee</u> 16th December, 2008. Councillor Purdue-Horan gave a brief report and the following recommendations were approved:-
 - (a) Folio 5963 Agreed to request up to £120,000.00 from the Community Chest held by Rushcliffe Borough Council to fund the costs attributed to contaminated land at Butt Field.
 - (b) Folio 5963/4 Civil Ceremony Licence and Increase in Hire Charges. It was agreed to renew the Civil Ceremony Licence at a cost of £1,250.00 and also to increase the hire charges for The Old Court House Council Chamber and meeting room by fifty per cent, i.e. Council Chamber hire charge from 1st April, 2009, to be £15.00 per hour and commercial rate at £9.00 per hour for Meeting Room. All other criteria based on above figures.
 - (c) Folio 5963/6 Budget & Precept 2009/2010. The Civil Licence Fee was amended to read £1,250.00 instead of £1,200.00 within The Old Court House budget which sits within finance. This increased the overall budget to £184,720.00 from £184,670.00. It was agreed to request a precept of £184,720.00 from Rushcliffe Borough Council.

A Rushcliffe Borough Council monitoring form had been given to the resident and it was also agreed to refer the matter to the next meeting of the Environment Committee and police.

04 Eco Town

An e-mail had been received confirming that R.A.F. Newton was to remain on the list of possible sites and was going forward to the next stage.

11.00 OBSERVATIONS FROM MEMBERS OF THE PUBLIC:

- 01 The effectiveness of the Town Council was queried in relation to the glass recycling project. The Town Mayor responded accordingly.
- 02 A representative of the Butt Field project confirmed that grant-funding had been secured in relation to a wind turbine to the tune of approximately £31,000.00 on top of funding for G.S.H.P. Floodlighting applications were in process. The representative also stated disappointment on the decision not to support the grant aid application from the Twinning Association. An email invitation to Councillors to join the Football Club on its twinning trip was offered to members. The Mayor thanked the representative for all his hard work in relation to the Butt Field project.
- 03 A resident raised a query re. interactive speed signs and an article in the 'Bingham Diary'. Councillors confirmed that Nottinghamshire County Council had confirmed Bingham had been included in next year's budget.
- 04 A resident queried a glass recycling site and requested its removal from Mill Hill. A Councillor responded by confirming that Rushcliffe Borough Council's Streetwise always responded quickly to any problems and it was felt that the site should remain. Another resident supported the removal of the site, despite not living near to it, and felt the answer was to support kerbside collections.
