1.00 APOLOGIES FOR ABSENCE:

There were no Apologies for Absence received.

2.00 MINUTES:

The Minutes of the meetings held on the 5th May and 23rd June, 2009, having been circulated prior to the meeting, were taken as read, approved and signed by the Chairman as a true record. Due to his spell in hospital, Councillor Purdue-Horan abstained from this vote but thanked everyone for their good wishes and went on to congratulate Councillor Mrs. M. Stockwood on being appointed Town Mayor and offered his full support.

3.00 COMMITTEE REPORTS:

The Chairman or Committee representatives of the individual Committees gave a brief report on the relevant Minutes, and the following recommendations were made:-

Reference was made to the fact that Rushcliffe Borough Council had granted a six day licence for a fruit and vegetable stall on the Market Square without any consultation with the Town Council. On the subject of vandalism at the Hill Drive allotments, it was agreed that letters should be sent to tenants, requesting the importance of keeping the gates locked.

The Clerk confirmed that discussions were being held with David Wilson Homes regarding the grassed areas within their new housing development. Councillor Purdue-Horan thanked the Chairman of the Environment Committee, and fellow members, for all their hard work on that Committee.

5.00 COMMUNITY BUILDING WORKING GROUP:

Councillor Purdue-Horan presented a generic plan (6247 KO2 Rev. A) of the proposed Community Centre, along with a brief outline as to how it had been arrived at. The plan was subject to amendment, and merely a starting point to go forward, and, as yet, was not site-specific as a definitive site had not yet been agreed. This was also dependent on the siting of the Health Centre. Councillor Purdue-Horan estimated that the cost would be in the region of £1.5m for building only and would be subject to public consultation later on in the year. Some Councillors expressed the importance of consultation in order to identify current need and expectations of members of the public. Consultation should take place at the beginning rather than end of the design stage.

6.00 WALLENFELS PLAY AREA WORKING GROUP:

Councillor Barnett confirmed that representatives of four companies had submitted plans and given presentations based on site visits and meetings. The working group of Councillors Barnett, Abbey and Shelton

RECOMMENDED to the Policy & Resources Committee Jon Walker Timber Products Limited as the preferred supplier. Once approved, then public consultation would take place on the proposed plans.

The Mayor thanked the working group for its hard work and a vote was taken. It was

RESOLVED to approve Jon Walker Timber Products Limited as the preferred supplier.

7.00 BUTT FIELD SPORTS GROUND:

01 Outstanding Pitch Works

It was agreed to grant approval to the Butt Field Working Group to progress pitch works as per the quotation from Fine Turf dated 23rd June, 2009, as follows:-

- (a) Item 1 @ £825.00 + Clubhouse reinstatement works items 1 – 6 @ £4,850.00.
- (b) The matter of rabbit netting to be referred back to the Butt Field Working Group for further recommendations to be made.

02 Dog Signage

An application had been received asking for permission to use the playing field for two fundraising events – a Beer Festival in June, 2009, and a car boot sale towards the end of July or beginning of August, 2009. It was

9.00 TO RECEIVE AND CONSIDER CORRESPONDENCE:

01 Rushcliffe Borough Council

Notification had been received of the granting of a licence for a stall on the Market Square on days other than a Thursday. Councillors expressed disappointment that the Town Council had not been consulted and felt that such an issue should go through the planning process. The general feeling was that the Town Council supported local shops and did not want to seem them boarded up, especially around the Market Square. The Clerk confirmed that the Borough Council had apologised for not consulting the Town Council. Bingham Town Council's long-term views of the Market Square would be referred to the Community Committee to be held on Tuesday, 14th July, 2009.

02 A letter had been received from the Mayor of Rushcliffe, Councillor Peter McGowan, expressing his thanks for the invitation to the Town Fair which he had subsequently thoroughly enjoyed.

03 A letter had been received from the Borough Council, inviting the Town Council to assist with fundraising for the Mayor's Charity Appeal which is the Neonatal Unit at the Nottingham University Hospitals' Trust.

04 Rushcliffe Development Framework Core Strategy

05 Tesco

Notification had been received that Tesco would be holding public consultations at The Old Court House regarding a possible store on the Sercon site, parallel to the railway line. A meeting had been held with Bingham Town Council and Borough Councillors. However, at this stage, no formal planning application had been received.

10.00 MEMBERS OF THE PUBLIC TO ASK QUESTIONS AND MAKE OBSERVATIONS TO THE TOWN COUNCIL:

01 A representative from the Dog Owners' Group thanked Councillors for listening to the Group. However, it was felt there were still issues to be addressed, i.e. signs on the bridleway and extension to access of free doggy bags which the Town Council provides. The Clerk was trying to arrange a meeting with the Group at which any outstanding problems would be addressed.

10.00 MEMBERS OF THE PUBLIC TO ASK QUESTIONS AND MAKE OBSERVATIONS TO THE TOWN COUNCIL continued.....

- 02 A resident expressed concern over the balancing pond on the proposed Wallenfels play area site. Councillors confirmed that the play equipment would be erected on the opposite side of the path within the green space. Another resident was pleased at the proposed new play area.
- 03 Residents expressed concern over the approach to the proposed Community Centre. However, Councillor Purdue-Horan went on to say it was hoped that a successful partnership, along similar lines to that with the Butt Field Sports Club, could be replicated in the approach to the Community Centre.
- 04 Concern was stated by some people about the proposed Tesco store as it was felt that local shops would be the casualties.
- 05 Reference was made by some residents about the huge problem of buses travelling along Cherry Street and Market Street. One resident also complained about traffic mounting the pavement near to the Halifax Bank on Market Street. It was agreed to refer this item to the Environment Committee.
- 06 A representative from the Butt Field Sport Club confirmed the opening weekend had been a great success and had surpassed all expectations.
