#### 01 F7222/8.06 – Eaton Place Toilets

It was reported that a RADAR key cannot be fitted to Eaton Place toilets due to specifications of the door. It was also noted that a complaint had been received regarding these toilets which has been forwarded to Rushcliffe Borough Council for attention.

- 01 Recent Changes of Traffic Regulation Orders and Impact on Traffic Flow and Parking
  - (a) One-way street appears to be working well.
  - (b) Pavement resurfacing has been completed.

- O1 Recent Changes of Traffic Regulation Orders and Impact on Traffic Flow and Parking continued.....
  - (c) Scheme itself appears to have a few flaws, i.e.
    - Disabled-bay markings painted against a railing, and, therefore, passenger door could not be opened.
    - Parking bay markings fall over dropped kerbs in at least three locations (Church Street; Frank Inness corner; approximately at end of Station Street on to Market Place it previously stated 'Keep Clear' yet the parking bay now falls across it; outside Pods & Petals shop).
    - Parking-bay falls across the access to NatWest Bank car park entrance.
    - Narrow width of parking bays, especially on Market Street.
    - Yellow lines across Borough Council parking bays around Market Place.
    - No yellow lines on Foster's Lane/East Street/Long Acre.
    - Right-hand turn from Union Street is too tight for larger vehicles as currently there are cones, etc. in that area on Market Street.
  - (d) Further consultation should have taken place with residents on Cherry Street/Long Acre. Clerk to chase for update.
  - (e) Clerk to chase Rushcliffe Borough Council re. update to amending period of time parking allowed in Market Place laybys on Thursdays.

County Councillor Suthers confirmed that the errors in relation to the scheme were currently being investigated at the County Council and he invited the Town Council to submit its findings. The parking survey was imminent and would be undertaken over two days (one being a market day) and it had also been amended to include parking on The Banks.
