01 Bridge – Update

02 Station Platforms - Update

The Clerk confirmed that a ramp had been fixed to the station platform just outside the station building with a sign suggesting that coaches one and two would stop at that point. This raised platform, presumably, was to assist travellers getting on and off the trains!

6.00 MATTERS RELATING TO HIGHWAYS:-

County Councillor Suthers confirmed that the public consultation in relation to the following would take place shortly with the firm URS undertaking them all at the same time:-

- 01 Proposed One-Way Street System for Market Street
- 02 Yellow Lines on Cherry Street and Foster's Lane
- Parking An incident caused by a car parked on double yellow lines on the corner of Station Street was noted and Councillors supported that the problem of illegally parked cars should be addressed and followed through by the relevant enforcement officers.
- 03 Market Place Laybys During Thursday Market

Councillors acknowledged that a formal request should be sent to Rushcliffe Borough Council supporting a change to the traffic regulations covering the Market Place laybys. As previously requested, the restriction should end nearer to the time that the actual market finishes, rather than the current time of 6.00 p.m. The Clerk to write to the Borough and County Councils requesting a change to the Traffic Regulation Orders. County Councillor Suthers also to progress the matter.
