Councillor Fox reported on the fourth meeting of the P.S.W.G. held on the 10th September, 2014, attended by a representative from the Crown Estate (refer Appendicès A, B and C attached).

01 Development North of Railway

- The Crown Estate expects to appoint a developer by 2015.
- The first properties may be built in 2016/17.
- 1.2 hectares of leisure land have been identified outside the Development Plan Area.
- Land for forty station car-parking spaces lies outside Development Plan boundary.
- P.S.W.G. will be reporting back to Crown Estate on progress.

02 N.C.C. Parking Survey

(a) Bus-Users' Survey

There was no evidence that a large number of people are using the centre of Bingham to 'park & ride' into Nottingham.

(b) Parking Analysis – Centre of Bingham

Results showed that:-

- Two thousand vehicles were parked in the centre of Bingham between 09.00 and 19.00 hours on both days of the survey.
- Ten per cent (i.e. two hundred vehicles) were parked for more than five hours.

6.00 PARKING STRATEGY WORKING GROUP P.S.W.G.) - UPDATE continued......

(a) Parking Analysis – Centre of Bingham

 Two thirds of the one hundred and fifty available spaces were occupied by vehicles parked for over five hours.

The survey provided important information for the P.S.W.G. who would be preparing a follow-on survey to establish a pattern of parking habits. It was intended to distribute the second survey to Bingham businesses/traders and establish if any spare spaces existed.

Although it was adequate for the working group to acquire information to progress its remit, it was agreed that the draft survey would be circulated to all Councillors for review before it was printed and distributed,

It was important that Councillors were kept up-to-date with actions and recommendations from working group meetings.

It was agreed that the final Nottinghamshire County Council Parking Survey should be circulated to all Councillors.

7.00 NOTTINGHAMSHIRE COUNTY COUNCIL'S RESPONSE IN RELATION TO GRASS-CUTTING IN AND AROUND BINGHAM, ALONG WITH QUOTATIONS OBTAINED:

The Town Council is concerned by the variable standards and frequency of grass-cutting in the town which is currently carried out by four separate agencies.

A cost/time analysis was carried out on Nottinghamshire County Council areas and sports grounds with the aim of consolidating all the areas under the responsibility of the Town Council in order to improve the overall standard.

The additional time required to enlarge the grass-cutting areas and increase frequency equates to the time currently spent cutting one of the sports grounds per annum.

Quotations for cutting the sports grounds were received, which amounted to approximately £4,468.00 for one sports ground per year.

7.00 NOTTINGHAMSHIRE COUNTY COUNCIL'S REPONSE IN RELATION TO GRASS-CUTTING IN AND AROUND BINGHAM, ALONG WITH QUOTATIONS OBTAINED continued........

RECOMMENDED that Bingham Town Council takes on all of Nottinghamshire County Council's grass verges and receives £2,798.20 (noting that the Town Council already receives approximately £1,250.00, i.e. only an additional £1,548.20 being received), it will be necessary to outsource one of the sports grounds. As a guide quote = £4,468.75, less £1,548.20 (additional income received from Nottinghamshire County Council) = shortfall of £2,920.55.

RECOMMENDED that the agreement runs for a trial period of three years in order to assess consistency of costs to Bingham Town Council and income from Nottinghamshire County Council, and to monitor grass-growing conditions.

The Mayor reported his efforts to enter into a discussion with the Crown Estates (CE) on the progress of the development north of the railway line. He is concerned that Bingham Town Council (BTC) will not have any input into the plans for the development.

It was agreed that although the CE have indicated a parking for 40 spaces on the outline plans, BTC need to provide a long term parking solution for the town.

Access to the proposed contaminated land area is currently very difficult, but Tesco have an obligation to create a tarmaced road to the Butt Field entrance via their goods vehicle access road. In the short term this was felt to be a viable access solution.

North of the contaminated land there is a 1.2ha area leading up to the 'hammer head' which is designated on the plans for Leisure & Wellbeing. This land will be given to the Borough Council (RBC) for either of 2 uses:- a) sell the land for employment use and use that money to provide a Leisure facility elsewhere in the Borough or b) Build a Leisure facility on that land.

What we need is a commitment from CE that if we proceed with building a long stay car park on the contaminated land, they will give BTC the £240,000 to help pay for it. It is proposed that a Public Works Loan for £700,000 over 25 years would be needed. It was agreed that as RBC are responsible for parking in Bingham, they should bear the cost of some of the work.

If a Leisure Centre is built on the land it would have to have a specified number of parking spaces which could potentially be made available for long stay use. | | The cost of the station parking as identified on the outline plans was purely for the CE to identify it as a possible need and place a value to it. Again this element is not part of the development. The location of that 40 spaces parking was never intended to be final. It was included only for the purposes of the outline plans. | |
| | The committee asked Neil for an assurance that should we go ahead with building a car park on the contaminated land, the CE would give the £240,000 to BTC to offset some of the cost. Neil was unable to give that assurance as if in the unlikely event that the development did not progress, the funding would not be available. The viability of the development will be triggered when the first engineering works are carried out. The first unit is expected to be 2016-2017. The clock starts ticking after the first dwelling is built. | |
