(c) H.G.V. Signs

No response had been received from any of the agencies involved in resigning on the A52. Clerk to follow up.

(d) Mallow Way – Proposed Bus Route

Responses from residents had been positive – they would welcome the alteration to the bus route.

(e) Long Acre Zebra Crossing

A site meeting has taken place and a number of options considered, but, as yet, no idea has been adopted.

(f) Tythby Road Bridge

Exploratory work would be taking place shortly to locate services. In addition, pruning of trees adjacent to the bridge would be carried out during the following two weeks to allow erection of scaffolding prior to bridge works. Clerk to inform Friends of Linear Park.

It is anticipated that work will commence in late August/early September, necessitating a road closure of four to five months. To date, no public notice of diversion route had been published.

(g) Cycle Route

Signs had been painted upside down on the path at The Banks. Councillors were disappointed at the casual attitude of the County Council to the cost of remedial works.

4.00 PROPOSAL FOR ECO TOWN:

The Committee felt that it was unsure of the definition of an 'Eco town'. The following points were made:-

- ➤ The Government had identified Rushcliffe as a suitable location for the development of additional housing, although the proposals are not clear at present.
- ➤ Rushcliffe Borough Council is taking the matter very seriously and has arranged an extraordinary meeting on the 8th May, 2008. There is also the opportunity for residents to air their views at the Annual Town Meeting on the 29th April, 2008.
- An 'Eco' town by definition should be self-contained.
- ➤ The former R.A.F. Newton site was refused permission as an asylum site.
- ➤ No development should be taking place on the Newton site until the A46 is dualled.
- ➤ Much more information is needed before the Town Council can express an informed opinion.

The following items of correspondence were received for consideration:-

- (a) <u>E-mail from Mr. Wilson re. (i) Speed Control and Possible Crossing,</u> <u>Grantham Road, and (ii) Open Space off Grantham Road</u>
