1.00 <u>MINUTES</u>:

The Minutes of the meeting held on the 20th July, 2010, having been circulated prior to the meeting, were taken as read, approved and signed by the Chairman as a correct record.

2.00 <u>MATTERS ARISING</u>:

There were no matters arising out of the Minutes of the meeting held on the 20th July, 2010, for information to report.

3.00 BUS STOPS/STANDS:

Mr. Jarek Bien was welcomed to the meeting to give an update on the County's suggestions for town centre improvements and agreement to investigate options for a future scheme.

Town Councillors' made the following observations:-

- (a) Scheme time limit restrictions should also cover Sundays.
- (b) Buses parking closer to congested Market Street/Church Street junction may hinder traffic flow, both for buses negotiating parked vehicles on Market Street and other vehicles seeking to turn into Church Street.

3.00 <u>BUS_STOPS/STANDS</u> continued......

- (c) Newgate Street is a particularly narrow street on which to accommodate a formal bus-sparking place.
- (d) Any bus-parking place on Newgate Street may limit access to the loading area at the rear of Eaton Place shops.
- (e) Bank security may present a problem if the security vans could not stop directly outside the NatWest bank in the Market Place.
- (f) The 'No Waiting by Buses at Any Time' area appears far larger than necessary. The knock-on effect will be buses waiting just outside the specified.
- (g) Any scheme should seek the support of local businesses and bus companies.
 - (h) Effectiveness of the scheme is linked to effectiveness of parking enforcement.

5.00 HANGING BASKETS - UPDATE:

Following Nottinghamshire County Council's instructions that its permission had to be sought and street lighting columns had to be stress-tested before having flower baskets attached to them, the Chairman confirmed that some of the flower baskets had been re-sited and ten street-lighting columns had been stress-tested. Flower baskets that could not be re-sited were repositioned outside The Old Court House and along the railings to St. Mary & All Saints Parish Church. It was agreed that the Chairman and Vice-Chairman should look into alternative flower towers, etc. for the next years, bearing in mind that this year was the first year of a three year contract for the supply of the floral displays.

6.00 DOG LITTER BINS - UPDATE:

In an effort to investigate options for improving the way dog litter bins are managed, the Clerk provided a map of current locations of both Bingham Town Council and Rushcliffe Borough Council dog bins. The Chairman confirmed that certain enquiries had been made at Rushcliffe Borough Council. It was agreed that the Chairman and Vice-Chairman should progress this matter and, hopefully, ensure that both the Town and Borough Councils' information was accurate.

Suggestions for this scheme were considered and it was agreed to apply for additional trees to be planted on Butt Field.

9.00 **BUDGET PLANNING**:

It was agreed that budget items were the provision of dog bins, including emptying of same, and provision of floral displays.

10.00 BINGHAM 2020:

It was agreed that the issues highlighted were all inter-linked. However, traffic management, parking, transport and infrastructure were all priority issues.
