01 Meeting Report

Councillor Eagles gave an update of the meeting held on 17th February, 2009, with Streetwise. Councillors were told that Rushcliffe Borough Council is to take over grass cutting from Nottinghamshire County Council, who in turn would undertake tree pruning, etc.

02 Eaton Place

(a) The cleaning which had originally been scheduled for May/October, 2009, has been deemed as being too excessive as this could possible unseat the paving bricks. A sweeper has been purchased by the Borough Council and will eventually be in Bingham for a full day subject to a rota system.

 - (b) It was confirmed that the slope near the Library belongs to Nottinghamshire County Council; however, the County Council does not grit pavements. If Rushcliffe Borough Council is in the area and its employees have grit with them, then they will address the problem. However, if a problem arises, it should always be reported to Nottinghamshire County Council first. It was suggested that the Town Council should inspect the severity of the problem and then report back to the County Council. The Clerk was also asked to send a letter to Nottinghamshire Council re. the condition of the paving slope as this is very icy in inclement weather.

03 <u>Dog Bins</u>

A letter had been received from a resident requesting the siting of a dog bin on the main road near the bottom of Meadowsweet Hill. However, it was reported that Streetwise were not aware of any problems with the depositing of dog waste in the current bin.

04 Glass Recycling

Due to financial constraints, Rushcliffe Borough Council is not rolling micro-recycling sites across the Borough. Therefore, they are to be removed from Bingham. Those on Newgate Street are to remain but the assisted boxes scheme is to be terminated.

NOTES ON MEETING HELD 12TH JANUARY, 2009, WITH NCC. PAUL HILLIER & AND ANDY KIRK

Cllr. J.Eagles welcomed both N.C.C. Officers to the meeting AND thanked them for attending.

Paul Hillier confirmed that there was funding in 08/09 for improved HGV Signs. PH handed over to Andy Kirk.

Andy Kirk confirmed the following:

- There could be auto monitoring of HGV units eg. on time taken to pass through certain sites etc.
- HGV's were problematical along Tythby Rd/Long Acre & Grantham Rd due to access required to Bingham Shops etc.
- Accepted there was a big problem re HGV's entering Bingham (reference was made by Cllrs. to car transporters driving through)
- Steps would be taken to identify requirements when the A46 dualling work was undertaken
- Trying to keep vehicles on A52 to Saxondale rdabt via advisory signage. Weight limits should be self enforcing ie 71/2 tons keep out at all cost.
- Could make routes less attractive by making delays (ie. alternating give way chichanes; road humps) but these would affect everyone. Interactive signs would only be placed in Bingham which consequently would not have any affect on drivers already committed to driving through.
- Possible "Avoidance of Weigh Bridge" impacts on certain drivers.
- Potential for temporary wireless cameras on slc.
- Could remove "A46/A52" from signs at traffic lights& replace with "Bingham"
- Electronic warning signs some in place but there are a few problems which are being addressed.
- Andy to provide an update report at a later date.
- Tythby Road due to be open prior to 31.3.09 & then the bridge will include cycle/pedestrian pavements
