6.00 TRAFFIC:-

01 Zebra Crossing and Barrier on Grantham Road

Councillor Eagles referred to information provided by County Councillor Suthers in relation to Nottinghamshire County Council's Safer Routes to School Programme. The following installations are were also reported:-

- Pedestrian tactile crossings at Carnarvon Primary School
- Two-metre panel of guard rail across the footpath at Willow Road.
- Two-metres of pedestrian guard rail either side of the existing crossing on to Grantham Road.

Paul Hillier from Nottinghamshire County Council had also confirmed the following:-

- Grantham Road A zebra crossing would replace the existing bollards and this to be sited in the same location.
- None of the proposed cycle routes would have to be revisited.

02 Toucan Crossing, Nottingham Road
