**2.00 MATTERS ARISING FROM THE MINUTES (For information):**

01 Planning Decisions

The Acting Town Clerk confirmed that, whilst no notifications of planning decisions from Rushcliffe Borough Council were being reported tonight, a fully up-to-date list would be circulated in future.

02 For the rest of this Civic Year, the Rushcliffe Borough Council reference would be included in addition to the Bingham Town Council reference. From the 13th May, 2008, meeting, the Rushcliffe Borough Council reference only would be used. The Committee agreed this would be more efficient and aid identification of applications at various stages.

**3.00 CORRESPONDENCE:**

01 It was reported that Rushcliffe Borough Council had received notice of a proposed felling of a birch tree at 4, Long Acre East in Bingham's Conservation Area. The Council had determined not to make a Tree Preservation Order and had given permission for the felling to proceed.

02 It was reported that a resident had e-mailed regarding apparent discussions between Rushcliffe Borough Council and developers for the Redrow/Miller Homes development about how the swale might be finished, and expressed concern about what was apparently being proposed.

**Decision: NO OBJECTION** but an observation be made expressing concern that customers may not use the car park.

**08/19/FUL** – 7, Manor Road  
Single-storey side/rear extension  
**Decision: NO OBJECTION** but an observation be made expressing concern about the ‘terracing’ effect of the proposal.

**08/20/FUL** – 36, Honeysuckle Grove  
Extension to form garage  
**Decision: NO OBJECTION**
