01 <u>Bio-Diversity Project</u>

The Chairman presented the report on Enhancing Green Space in Bingham for Wildlife, a copy of which is available on request. It was agreed to support, in principle, the general recommendations such as leaving a one metre buffer zone in appropriate places, and, subject to available funding, progress other suggestions such as bat/bird boxes and additional planting details.

02 Future Improvements of Access to Butt Field

The Chairman made reference to previous enquiries regarding capping-off of Bingham Town Council's contaminated land and the current Tesco planning application which shows an access road towards the bridleway. This access road may open up a different access route to Butt Field, allowing a car park on the contaminated land area. Following a discussion regarding appointing an architect to produce detailed plans for such a scheme, it was agreed to defer the matter to a future meeting.

03 Agreement on Policy of Metal Detecting on Bingham Town Council Land

The Town Council had received an enquiry about metal detecting on its land. It was agreed, in principle, to allow metal detecting providing an annual agreement was signed prior to entry on to the land, with Bingham Town Council retaining seventy-five per cent of the value of any finds over £20.00 The cemetery, sports pitches and equipped play areas would be excluded. cent of the un licens	that in consideration of the payment to the landowner/occupier of seventy-five per of the value or rewards arising from the recovery of any property or objects found by indersigned (hereinafter called 'the licensee(s)' over the value of twenty pounds, the ee(s) may enter the said land, or part thereof, to search for items of buried or other ital, whether antique or modern.
	annual Agreement shall continue in force from (date)until
1.	The licensee(s) shall hold a current N.C.M.D. membership card showing details of their £10,000.000 Public Liability Insurance cover.
2.	The licensee(s) shall always observe and adhere to the Code of Conduct as set out by the N.C.M.D. which is a condition of membership and includes reference to the voluntary Code of Practise for Responsible Metal Detecting. (See overleaf).
3.	The licensee(s) shall strictly observe and adhere to any guidelines or special conditions and area boundaries which may be set out by the owner/occupier from time to time, and to any terms and conditions with respect to metal detecting access specified in agri-environment agreements which may cover all or part of the said land.
4.	The licensee(s) shall record finds made on the said land with third parties, including the Portable Antiquities Scheme (P.A.S.), Historic Environment Records (H.E.R.), or any museum service only after gaining the appropriate permission of the landowner to do so, and then only to an accuracy of find-spots that all parties are comfortable with. All parties must abide by the terms and conditions of any agrienvironment schemes that specify mandatory reporting of all finds made on land covered by such agreements with the P.A.S. (Agri-Environmental Schemes are not applicable to Scotland and Wales).

THE NATIONAL COUNCIL FOR METAL DETECTING CODE OF CONDUCT

- 1. Do not trespass. Obtain permission before venturing on to any land.
- 2. Respect the Country Code, leave gates and property as you find them and do not damage crops, frighten animals or disturb nesting birds.
- 3. Wherever the site, do not leave a mess or an unsafe surface for those who may follow. It is perfectly simple to extract a coin or other small object buried a few inches below the ground without digging a great hole. Use a suitable digging implement to cut a neat flap (do not remove the plug of earth entirely from the ground), extract the object, reinstate the grass, sand or soil carefully, and even you will have difficulty in locating the find spot again.
- 4. If you discover any live ammunition, or any lethal object such as an unexploded bomb or mine, do not disturb it. Mark the site carefully and report the find to the local police and landowner.
- 5. Help keep Britain Tidy. Safely dispose of refuse you come across.
- 6. Report all unusual historical finds to the landowner and acquaint yourself with current N.C.M.D. policy relating to the Voluntary Reporting of Portable Antiquities in England and Wales, and the mandatory reporting requirements in Scotland. See: http://www.treasuretrovescotland.co.uk/index.asp
- 7. Remember it is illegal for anyone to use a metal detector on a designated area (e.g. Scheduled Monuments (S.M.), Sites of Special Scientific Interest (S.S.S.I.), or Ministry of Defence property) without permission from the appropriate authority. It is also a condition of most agri-environment agreements that metal detecting access is subject to certain rules and regulations, including mandatory finds recording. Details of these agreements, and the access conditions they impose, are detailed on the N.C.M.D. website.
- 8. Acquaint yourself with the terms and definitions used in the following documents:
 - (a) Treasure contained in the Treasure Act 1996 and its associated Code of Practice making sure you understand your responsibilities.
 - (b) Advice for Finders of Archaeological Objects, including Treasure, 2006.
 - (c) The voluntary Code of Practise for Responsible Metal Detecting to which the N.C.M.D. is an endorsee.
 - (d) Advice for finders in Scotland. See: http://www.treasuretrovescotland.co.uk/htm/finders.asp
- 9. Remember that when you are out with your metal detector you are an ambassador for our hobby. Do nothing that might give it a bad name.
- 10. Never miss an opportunity to explain your hobby to anyone who asks about it.
