Councillor Purdue-Horan reported that at a recent Positive Futures meeting, a scheme to repaint the bridge over the Linear Walk under a Community Pride project in August was being considered and that further information would be forthcoming in the near future.

05 Removal of Shrubbery at Wynhill

The Clerk confirmed that a quotation had been obtained for removal of the shrubbery at Wynhill. The quotation was more than had been expected and also showed a separate amount for making good the area. The total cost was approximately £1,000.00. It was agreed that the Clerk refers back to the Rugby Club to determine what state the proposed new patio area was at and, possibly, obtain further quotations.
