Nottinghamshire County Council confirmed that the sign on the street lighting column on Chapel Lane opposite Moorbridge Road should be in place by the end of October, 2009.

02 Folio 6098/3.02 - Wallenfels Play Area Site – Update on Public Consultation

There had been a successful public consultation which had generated concerns from some residents on Goldcrest Close. The Clerk confirmed receipt of fifty-two completed questionnaires which, to date, had not been fully analysed.

Standing Orders were suspended in order to allow residents to speak

Councillor Barnett responded to the points raised in the letter received from residents of Goldcrest Close. He confirmed there had been no intention of deception but merely confusion as to where Nightingale Way ended and Goldcrest Close began. The correct properties had been taken into account; the open space in question was not Crown land as it had been handed over to Rushcliffe Borough Council and was now subject to being transferred to Bingham Town Council. The Mayor, Councillor Mrs. Stockwood reported that the area had been designated as a play area as long back as 1999.

The residents referred to N.P.F.A. Minimum Standards re. Local Equipped Play Areas (L.E.A.P.) and Neighbourhood Equipped Play Areas (N.E.A.P.), and the relevant buffer zones. Suggestions were also made that there were too many pieces of equipment for an area of that size.

Councillors confirmed that any issues raised would be addressed following the consultation and thanked the residents for participating in it. Following further investigations, residents would be contacted prior to any installation on the open space. Councillors felt it was necessary to address all concerns before going ahead.

The Clerk confirmed the need to set up a working party to visit all Bingham Town Council 's play areas to identify maintenance work required. It was suggested that Councillors Kerry, Abbey and the Town Clerk to be on the Working Party.

03 South Nottingham Hockey Club

An e-mail had been received from the above Club inquiring into the possibility of hockey facilities being incorporated on Butt Field, be it the old allotment site, skateboard park or within the edge of Butt Field. Toot Hill School was currently being used for hockey activities. Councillors felt the cost of utilising either the former Moor Lane allotment site or skateboard park would be prohibitive due to removal of the contaminated soil to a specialised site.

In view of the various factors concerning the above sites and the uncertainty of the new health centre location at this moment in time, Councillors felt they could not make any firm decisions.
