Comment relating to 19/02689/REM – it is disappointed that through the passage of time this innovative outline scheme with its orchard, green spaces, cycle track and social housing allocation has been diminished through variations to an unimaginative housing development. It also noted that there is no reference to the pedestrian bridge linking Newton and Bingham.

Comment relating to 19/02698/COU - that this address falls within the primary frontage definition. Bingham requires the right mix of shops, both retail and service to achieve a balanced shop frontage and wants to be sure that this application is treated in accordance with planning policy.
