NOTIFICATION OF ESSENTIAL DRAINAGE WORKS A52 GRANTHAM ROAD

I am writing to let you know that we will be carrying out essential drainage work to sections of Grantham Road, Radcliffe-on-Trent alongside the A52. The works are located on the A52 eastbound carriageway from the Bingham Road junction for approximately 300m.

The proposed works involve:

- replacing the existing kerbs with a combined drainage system complete with new out-fall which includes a new pipe connection into an existing manhole
- clearing and re-grading drainage ditches
- resurfacing and re-aligning the footway to improve water run-off
- dish channel drainage to the driveways on highway land and new infiltration trenches

Once complete, residents and motorists will benefit from reduced carriageway flooding and improving road safety.

When will the work take place?

Work is due to start **mid-January 2020** and is scheduled for completion by the end of **March 2020**.

To keep our programme for these works as short as possible and to minimise traffic disruption to the local community, residents, business and road users, we will work:

- between 8pm and 6am, Monday to Friday (week night closures)
- between 8pm and 8am Saturdays
- between 8pm and 9am Sundays

Please note that all our planned works are subject to change due to weather conditions or unforeseen circumstances.

How will the work affect traffic?

To maintain a safe environment for our workforce and customers, we will use a mixture of three-way temporary traffic lights and full closures along sections of the A52. All carriageways will remain open as usual outside our working hours, however a temporary speed limit restriction of 30mph will be in force for safety reasons.

During these closures we will put in place fully signed diversion routes which have been agreed with the Local Authority.

How will the work affect businesses and residents?

We will make sure that access to businesses and residences is maintained wherever possible.

We apologise for any inconvenience caused and will do our very best to complete the work as quickly as possible, keeping disturbances and noise to a minimum.
