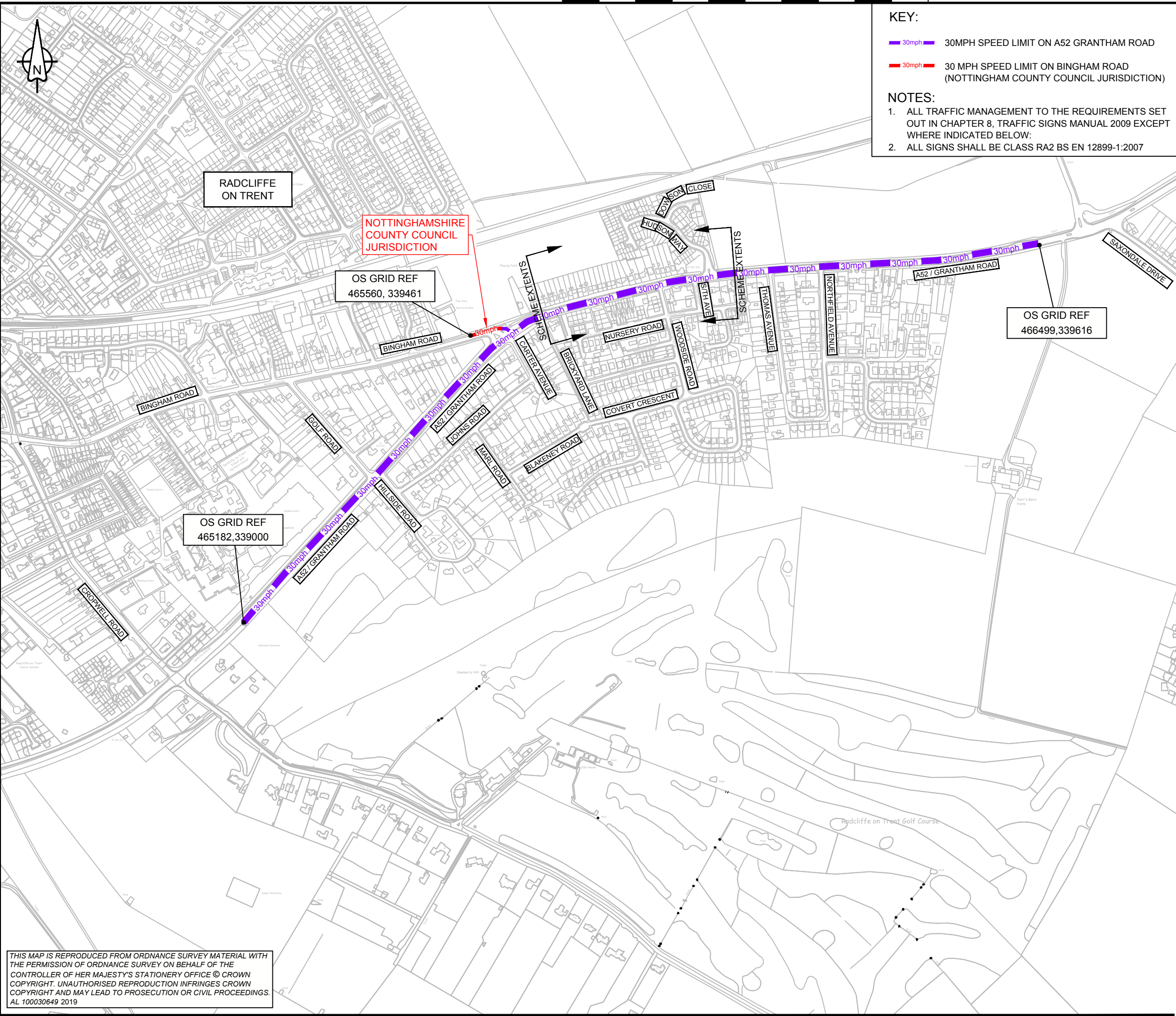

3. ALL REGULATORY AND WARNING SIGNS ON THE MOTORWAY SHALL BE 1500mm DIAMETER, TRUNK ROADS SHALL BE 1200mm EXCEPT ANY REPEATER SIGNS WHICH SHALL BE 900mm, SIDE ROADS SHALL BE 1200mm.
