THE NOTTINGHAMSHIRE COUNTY COUNCIL (TEMPORARY PROHIBITIONS) (BINGHAM REMEMBRANCE DAY PARADE) ORDER 2019 (R19-160)

<u>WHEREAS</u> the Nottinghamshire County Council (hereinafter called "the Council") being the traffic authority for the length of highway referred to in Article 1 of this Order is satisfied that the use of the said length of highway should be restricted for the purpose of facilitating the holding of an event on the said highway.

NOW THEREFORE the Council in exercise of its powers under Section 16A of the Road Traffic Regulation Act 1984, as amended, hereby makes the following Order:-

- 1. No vehicle shall proceed in the following lengths of road at Bingham in the Borough of Rushcliffe:
 - a) Newgate Street, between its junctions with Green Lane and Market Street
 - b) Market Street, between its junctions with Newgate Street and Moor Lane
 - c) Market Place, for its entire length
 - d) Church Street, between its junctions with Market Place and Cherry Street
 - e) Cherry Street, between its junctions with Long Acre and Church Street
- 2. Vehicles are prohibited from waiting, loading and unloading in the following length of road at Bingham in the Borough of Rushcliffe:
 - a) Newgate Street, between its junctions with Green Lane and Market Street
 - b) Market Street, between its junctions with Newgate Street and Moor Lane
 - c) Market Place, for its entire length
 - d) Church Street, between its junctions with Market Place and Cherry Street
 - e) Cherry Street, between its junctions with Long Acre and Church Street
- 2. No prohibition, restriction or prescription contained in this Order shall apply to any person acting in accordance with any permission or direction given by a Police Officer in uniform nor shall apply in respect of access required by emergency vehicles.
- 3. For so long as, and to the extent that, traffic signs (authorised under the Traffic Signs Regulations and General Directions in force on the date this Order is made) indicating the effect of the prohibitions contained in Articles 1 and 2 of this Order are placed or a direction is given by a Police Officer, that prohibition shall be enforced.
- 4. In this Order "event" means The Bingham Remembrance Day Parade, promoted by Bingham Town Council.
- 5. This Order may be cited as "THE NOTTINGHAMSHIRE COUNTY COUNCIL (BINGHAM REMEMBRANCE DAY PARADE) ORDER 2019 (R19-160)" and shall come into force on 10th day of November 2019.
