### **NOTIFICATION OF ESSENTIAL WORKS - A52 Gamston Roundabout to Wheatcroft Roundabout and A52 Grantham Road, Radcliffe on Trent**

#### **A52 Gamston Roundabout to Wheatcroft Roundabout**

We are currently carrying out essential lighting maintenance works on the A52, from the Gamston roundabout to the Wheatcroft roundabout.

Due to the poor weather experienced on site over the past few weeks, our works have been delayed and will **extend beyond** our forecasted end date of **25 January 2020**. We have scheduled the remaining work to be completed overnight from **8pm** until **6am** through to mid-February.

#### **A52 Grantham Road, Radcliffe on Trent**

We will also carry out essential drainage work to sections of Grantham Road, Radcliffe-on-Trent, alongside the A52 eastbound carriageway from the Bingham Road junction for approximately 300m.

This work is due to start **29 January 2020** and is scheduled for completion by **24 March 2020**.

To maintain a safe environment for our workforce and customers, approximately eight full overnight road closures of the A52 are required in both directions, between **8pm** and **6am**. The full closures are scheduled to take place at the start and at the end of the works programme.

These full road closures will start at the Bingham Road junction at Harlequin and cover the 300m length of our works at Radcliffe on Trent. We will also need to divert traffic, in advance, from the A52 Gamston roundabout and Saxondale roundabout in both directions while we work. Access will be permitted along the A52 up to the closure points at Harlequin.

Outside of the eight full road closures, we will complete our works using overnight temporary traffic signals.

During all road closures we will put in place fully signed diversion routes, which have been agreed with the Local Authority. All carriageways will be open as usual outside of our working times. For further detailed information about our road closures, please refer to the attached drawing.

Please note that all our planned roadworks may be subject to change due to weather conditions or unforeseen circumstances.
