1. APOLOGIES

10. BRIDLEWAY

The Council considered the recommendation from the Community, Recreation and Amenities Committee for financial support for the planned works on the bridleway leading to Butt Field Sports Club.

RESOLVED: that up to £4000 be allocated from the three year reserves budget for Butt Field Sports Club for maintenance work.

11. GRANT AID

The Grant Aid Application from Bingham Football Club was considered to support the summer visit to Bingham's Twinned Town of Wallenfels.

RESOLVED: to award £900 for T Shirt Gifts and Pennants.

12. TOWN MAP

A request to use the Town Map for a Bingham Safari Sale was considered, with all proceeds from the stall fees and maps being donated to Bingham Food Warriors.

RESOLVED: to agree use of the Town Map for the Bingham Safari Sale

13. COUNCILLOR REPORTS

Councillor G Williams confirmed that he had attended the AGM of Bingham Sports Club as a parent of a member of the Cricket Club. Queries had been raised to him as a Councillor in relation to the desire to progress the expansion of the Club and comments regarding the Bridleway repairs and budget. The comments regarding the Bridleway had been confirmed under item 10 and Councillor Williams confirmed to the Club that the Council were still aware of the desire for expansion at the site.

Councillor R Bird confirmed that he had two meetings arranged for July, the Police Priority Setting Meeting and a meeting with Carnarvon School regarding parking and traffic issues surrounding the school. It was requested that the increased policing patrols for West Bridgford be replicated for Bingham after the successful reduction in crime.
