I understand that failure (without reasonable excuse) to register or disclose any disclosable pecuniary interest, or participate in any discussion or vote in a matter in which I have a disclosable pecuniary interest is a criminal offence and risks a fine not exceeding level 5 on the standard scale (currently £5,000) or disqualification as a member for a period not exceeding 5 years.
