**1. APOLOGIES**

Apologies for absence were received and accepted from Councillors P Walters, T Wallace and S Perkins.

**2. DECLARATIONS OF INTEREST**

No declarations of interest were received.

The Mayor thanked all those that attended the annual Civic Service and passed on thanks to the staff for arranging the service.

**4. QUESTIONS AND COMMENTS FROM MEMBERS OF THE PUBLIC**

**5. COUNTY AND BOROUGH COUNCILLOR REPORTS**

County Councillor N Clarke confirmed that additional resources had been allocated to clearing drains and that road repairs had received an increased budget. Residents' concerns over the queuing traffic on Chapel Lane had been raised with officers. Options including contact with Lidl for a second left exit lane would be progressed by officers. A consultation for yellow lines along one side of Long Acre was being progressed and would include a box junction outside of the Fire Station.

Borough Councillor G Williams confirmed the latest UKSPF Funding opportunity available and the consultation on the Greater Nottinghamshire Strategic Plan.

Councillor G Williams had no update to announce from Bingham Twinning Association and confirmed that the flood light awaiting replacement at Butt Field had now been completed.

The Clerk confirmed that the Crown Estates had experienced numerous incidents of damage to the new fencing installed at Starnhill adjacent to the Linear Park. The police had been informed and the damage was repeatedly taking place, officers asked that any suspicious activity be reported.
