**RESOLVED:** to install dogs under control signage in appropriate locations at Wynhill.

**RESOLVED:** to grant approval for the removal of the secondary gate leading onto the playing field at Wynhill.

(c) Planning application update for temporary changing facilities

The committee noted the update.
