NOTE: The nominal value of shares is the face value of those shares (the value recorded on the share certificate)

I have set out above my interests, and those of my spouse/civil partner (or person with whom I am living as such) of which I am aware, which I am required to declare under the Council's Code of Conduct.

I understand that I must, within 28 days of becoming aware of any new interest or change in the interests declared, provide written notification to Rushcliffe Borough Council's Monitoring Officer.

I recognise that it is a breach of the Council's Code of Conduct to fail to register interests that ought to be registered; provide information that is materially false or misleading; or fail to notify the Monitoring Officer in writing of any changes within 28 days.

I understand that failure (without reasonable excuse) to register or disclose any disclosable pecuniary interest, or participate in any discussion or vote in a matter in which I have a disclosable pecuniary interest is a criminal offence and risks a fine not exceeding level 5 on the standard scale (currently £5,000) or disqualification as a member for a period not exceeding 5 years.
